

This means the numbers of confirmed cases may not be directly comparable with previous reports. For reasons of confidentiality, the rates are now shown as ranges, as numbers are now very low by ward.</p> <p><sup>1</sup>infection (incidence) rate - the cumulative number of confirmed cases of COVID-19 for the 7-day period divided by the total population of each area multiplied by 100,000  <sup>2</sup>A rank of the rate of COVID-19 per 100,000 by local authority. There are 314 lower tier local authorities in England. 
## CONFIRMED COVID-19 CASES BY AGE AND GENDER





## ETHNICITY OF CONFIRMED COVID-19 CASES




## ETHNICITY OF COVID-19 DEATHS

cumulative number of COVID-19 related deaths in Wirral




**Note:** The above data has followed the methodology of the PHE indicator for 'Deaths within 28 days of a positive COVID-19 test' since reporting for week ending 30<sup>th</sup> October and is therefore not comparable to reports prior to that week. The figures are still derived using a local live data source and so will therefore not exactly match the number of deaths officially reported by the Office for National Statistics or the PHE Coronavirus Tracker. Further validation of the external data sources with fully coded dates has now led to changes in the numbers reported. Some records do not currently have full age and/or gender details and are therefore not included in the above chart; therefore, figures will not sum to headline totals. Cases are subject to retrospective review and can may be reallocated to other Local Authorities.

## EPIDEMIC CURVE


number of positive cases by Pillar 1 and Pillar 2 testing<sup>5</sup>

 Pillar 2 data is for swab testing for the wider population, as set out in government guidance  
 LFT (lateral flow device) data is for rapid tests in the community (which also make up part of Pillar 2 testing)
